<b>REASON</b>	This recall is being initiated due to a loss on drying out-of-specification result for Meclizine Hydrochloride Tablets, USP in the American Health Packaging repackaged configuration.		
<b>PRODUCT INDICATION</b>	Meclizine hydrochloride tablets are indicated for the treatment of vertigo associated with diseases affecting the vestibular system in adults.		
<b>HEALTH HAZARD EVALUATION</b>	The isolated loss-on-drying value of 5.3% does not present a meaningful risk to patient safety or therapeutic effectiveness, as product stability, performance, and chemical integrity remain supported by available data.
